**NOTICE:** In an effort to control the spread of the COVID-19 virus, California Governor Gavin Newsom issued Executive Order N-33-20 on March 19, 2020. Order N-33-20 obligates all residents in the State of California to stay home and heed the public health directives issued by the Department of Public Health. As a result, the District will be unable to offer its meeting room to hold this regular meeting. Instead, the meeting will be held entirely by Virtual Meeting Via Zoom / telephone, consistent with Executive Order N-29-20, which waived certain provisions of the Brown Act. District directors and members of the public may participate in the meeting using the same Zoom Meeting access information listed below, as authorized by Executive Order N-29-20. If the mode of communication changes, the District will use the most rapid means of communication available at the time.

The greater flexibility provided by the Executive Order will be useful in protecting the health and safety of local public agency board members, staff, and members of the public during the COVID-19 pandemic without halting progress on the public's business or eliminating public access to decision-making. Agencies may choose to take additional precautions such as including language in their agendas advising those who are sick to please consider participating in meetings remotely.
